Entry Conditions and Parent/Guardian Waiver for Riders

This form, signed by the Rider and the Parent/Guardian of the rider must be brought to Race Registration before the rider will be allowed to enter.

Representations and Warranties: I represent and warrant in favour of the Licensor as follows: (1) I am in good Physical condition and have no disability, impairment or ailment that will prevent me from engaging in the Event or that will be detrimental to my health, safety or physical condition of others while participating in the Event or while at or near the Event.

Release and Indemnity: I hereby release and forever discharge each of the Licenser, its officers, directors, Employees, agents and contractors and sponsors, from any and all claims, suits, demands, expenses, costs, Actions and proceedings of any nature whatsoever, which I, my executors or administrators or any other person has or might assert against any of them arising from, in relation to, incidental to or by virtue of any injury, loss or Damage suffered or sustained by me in connection with my participation in the Event or at any time when I am near The Event. I hereby indemnify and hold hamless, and shall keep indemnified and held hamless, each of the Licensor, its officers, directors, agents, contractors and sponsors from and against all claims, suits, demands, Expenses, costs, actions and proceedings of any nature whatsoever arising from, in relation to or by virtue of: (1) Any injury, loss or damage sustained by me. (2) Any injury, loss or damage suffered by any other person as a Result of any act, omission, neglect or default on my part, in connection with my participation in the Event or at any Time when I am near the Event. I acknowledge that the MTBA Day Licence insurance covers myself for public liability and personal indemnity whilst participating in this event between 1100 and 1730 on 24th August 2017; between 0800 and 1600 on 25th August 2017; I agree to wear an Australian Standards approved cycling helmet whilst riding a bike at all times during this period. I agree that I am responsible for my personal accident insurance, ambulance cover and any medical costs not covered by the MTBA Day License Insurance.

I hereby agree to allow the rider's name, results, photographs, video, audio recordings, multimedia or film likeness to be used for any legitimate purpose by Canberra Off-Road Cyclists (CORC), the sponsors, or assigns. I have been fully informed that a DVD of the event may be made and distributed to Australian Secondary Schools and may be shown in public for the purpose of promoting the sport of mountain biking. I agree to allow the rider to appear in such a DVD¹. CORC reserves the right to refuse entry to any competitor. CORC reserves the right to modify or alter the race course to provide suitable riding conditions during the event. CORC reserves the right to change any team name if in the sole opinion of the race director the name conflicts with other team names or is offensive in nature. I have carefully read this entry form and agree to abide by these race conditions. I agree to obey all the race rules, directions and decisions of all race officials whilst I am in the Stromlo Forest Park area on 24th to 25th August 2017.

All entrants must agree as having read and understood this declaration. This form printed and signed by the rider and the rider's parent or guardian must be brought to Race Registration on 24th or 25th August 2017 before you will be allowed to ride at the event, including riding for practice laps.
